

# Pupil premium strategy statement

# Part A: Pupil premium strategy plan

## Statement of intent

In making decisions about using Pupil Premium funding it is important to consider the context of the school and the subsequent challenges faced by pupils and the wider community.

Common barriers to learning for disadvantaged children can be: less support at home, weak language and communication skills, lack of confidence, more frequent behaviour difficulties and attendance and punctuality issues. There may also be complex family situations that prevent children from flourishing. The challenges are varied and there is no “one size fits all”.

At West Pennard will ensure that all teaching staff are involved in the analysis of data at Pupil Progress Meetings and the identification of pupils in need of support, so that they are fully aware of strengths and weaknesses across the school.

### Principles

- We ensure that teaching and learning opportunities meet the needs of all the pupils
- We ensure that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed
- In making provision for socially disadvantaged pupils, we recognise that not all pupils who receive free school meals will be socially disadvantaged
- We also recognise that not all pupils who are socially disadvantaged are registered for or qualify for free school meals. We reserve the right to allocate Pupil Premium funding to support any pupil or groups of pupils the school has legitimately identified as being socially disadvantaged.
- Pupil premium funding will be allocated following a needs analysis which will identify priority classes, groups or individuals. Limited funding and resources means that not all children receiving free school meals will be in receipt of pupil premium interventions at one time.

### Demography and School Context

West Pennard CE Primary School is a Church of England village school located in a rural setting. The school retains strong links with the local church, which is situated adjacent to the school. The Christian vision firmly underpins its foundations and links with the local clergy continue to strengthen. The school attracts pupils from a wide geographical area; including surrounding villages and local towns. Many children come from out of catchment. The school comprises 7 single year group classes. Currently there are 206 children on roll with a Pupils' Admission Number (PAN) of 30. The number on roll has dropped from last academic year, mainly due to fewer children starting in reception, reflective of an 8% drop in national birth rate. The proportion of children in receipt of Free School Meals is consistently below national averages. 18 out of 206

(9%). The national average is 22.5%. The percentage of pupils supported by the Pupil Premium is significantly below average and currently is 27 out of 206 pupils (13%).

### **Ultimate Objectives**

- To narrow the attainment gap between disadvantaged and non-disadvantaged pupils nationally and also within internal school data.
- For all disadvantaged pupils in school to exceed nationally expected progress rates in order to reach Age Related Expectation at the end of Year 6.

### **Achieving These Objectives**

The range of provision the Governors consider making for this group include and would not be limited to:

- Maintaining a high adult to pupil ratio in classes with full time and experienced TAs, thus improving opportunities for effective teaching and accelerated progress
- Targeting disadvantaged pupils in intervention sessions, providing small group work with an experienced teacher or TA focussed on overcoming gaps in learning
- 1-1 and small group support through targeted interventions
- Additional teaching and learning opportunities provided through external agencies e.g. Beanstalk
- Planning opportunities for a smooth transition from Primary to Secondary school and transition internally and into EYFS from the different pre-school settings.
- Contributing to activities such as wider musical opportunities, educational visits and residential visits. Ensuring children have first-hand experiences to use in their learning in the classroom.
- Supporting the funding of specialist learning software.
- Providing access to high quality resources, such as reading books through R4L and the school library.
- Supporting children with resources at home through the purchase of Nessy and other subscriptions
- Enabling the children to learn a musical instrument by part funding private tuition.
- Facilitating behaviour and nurture support during lunchtimes by providing activities to engage and promote West Pennard values and thus enhance learning.

This list is not exhaustive and will change according to the needs and support our socially disadvantaged pupils require.

## Challenges

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

To continue to ensure the outcomes for pupils in receipt of pupil premium are at least in line with those of peers in school across the curriculum through ensuring high quality teaching is effectively in place, alongside targeted interventions.	<p>Lesson observations and intervention logs demonstrate that children in receipt of Pupil premium are also in receipt of high quality teaching.</p> <p>In Years 1-6 the number of pupils at ARE in Reading (PP vs Non-PP) were broadly in line with 42% ARE and 43% ARE respectively. There was a gap between those reaching GD, with 8% PP and 18% non-PP. In terms of progress, 58% made expected progress and 42% above expected with a progress measure of +0.4</p> <p>In Years 1-6 the number of pupils at ARE in Writing (PP vs Non-PP) showed a gap in attainment with 33% ARE and 45% ARE respectively. There was a gap between those reaching GD, with 4% PP and 9% non-PP. In terms of progress, 58% made expected progress and 42% above expected with a progress measure of +0.5</p> <p>In Years 1-6 the number of pupils at ARE in Maths (PP vs Non-PP) were broadly in line with 46% ARE and 52% ARE respectively. Those reaching GD was also fairly similar with 8% PP and 9% non-PP reaching the higher standard. In terms of progress, 79% made expected progress and 21% above expected with a progress measure of +0.2</p>
